The Caedmon School determines its Flexible Tuition awards, our version of financial aid, on the family's ability to pay, as demonstrated by information that is provided by the family to School and Student Services (SSS) through the application, Parent Financial Statement (PFS) and supporting documentation. Both custodial and non-custodial parents, regardless of legal settlements, who are divorced, separated, or never married are expected to contribute to educational costs and are required to submit the application. A lack of information from either parent may prevent the family from receiving a flexible tuition grant.

The Flexible Tuition committee can waive the non-custodial requirement in certain situations. The conditions under which this may be considered are usually:

- 1. The non-custodial parent's whereabouts are unknown.
- 2. The non-custodial parent has no contact and has not had any contact with the applicant over a period of years.
- 3. The non-custodial parent provides no financial support of any kind or amount for the benefit of the student.

Additionally, some students have a single parent without any non-custodial parent. The non-custodial requirement may be waived in these situations, when:

- 1. The custodial parent has been a single parent (no other parent is named on their birth certificate) since the student's birth.
- 2. The student's other parent is deceased.

This is a petition requesting the non-custodial parent requirement be waived for your submission of Flexible Tuition or financial aid application forms through School and Student Services (SSS). Upon receiving this petition, our committee will review and respond to your request. Please complete the entire form. Answer all questions and submit all requested documentation. **Only completed petitions will be reviewed.**
